

# **Christmas Party Event - Terms and Conditions**

### 1. General Information

By purchasing a ticket or attending the Event, you agree to abide by these Terms.

# 2. Event Organiser

This event is organised by Compton Care, a registered charity in England and Wales (Charity Number 512387), with its registered office at 4 Compton Road West, Compton, Wolverhampton, WV3 9DH.

### 3. Tickets and Admission

- Tickets must be purchased in advance via our website or authorised outlets.
- Tickets are non-refundable and non-transferable unless otherwise stated.
- Admission is only permitted with a valid QR-code ticket or registration confirmation.
- The Event organisers reserve the right to refuse entry to anyone who poses a safety or security risk or violates these Terms.
- Ticket purchases are regarded as acceptance of the terms and conditions.
- We reserve the right to change the seating plan to accommodate the requirements of the event.

### 4. Age Restrictions

• This is an 18+ event. Valid photo ID is required for entry.

# 5. Dress Code

• Party attire is encouraged but not mandatory. Management reserves the right to deny entry to individuals who are not appropriately dressed.

# 6. Food and Drink

 Food and beverages will be provided as per the event details. Bringing outside food and beverages is not permitted without prior authorisation. Alcohol will be served to guests aged 18 and over. Please drink responsibly.

# 7. Health and Safety

- Attendees must follow all venue rules and any instructions from event staff.
- We reserve the right to refuse entry or remove individuals for safety or behavioural reasons.
- All guests are expected to behave respectfully towards others. Harassment, abuse, or any form of disruptive behaviour will result in removal from the Event.
- Any damages caused to the venue or property may be charged to the responsible party.
- Please be aware that given the age of the venue there are accessibility issues for certain areas, please contact <u>fundraising@comptoncare.org.uk</u> or 0300 323 0250 before purchasing tickets if you have any mobility queries regarding access.
